Introduction of support services fee



To ensure that Russell Investments is being transparent with shareholders this notification confirms the intention to charge a support services fee for the services it provides to funds domiciled in Ireland. The ability to charge the support services fee is outlined in the prospectus for each fund umbrella. This overview provides further details of the rationale for this change.

Overview of the change

The prospectuses for the Irish fund range allow for Russell Investments Limited to charge a fee for the support services it provides.

Russell Investments do not currently charge this fee, however the scale of resource committed to supporting the funds has been assessed and Russell Investments has concluded that it is now necessary to charge the support services fee.

What are support services?

Carne Global Fund Managers (Ireland) Limited, the management company, delegates the provision of support services to Russell Investments.

These services fall outside of the distribution and investment management services provided by Russell Investments to the funds. They span all the activities that need to be conducted to ensure that the funds remain fit for purpose and compliant with the regulations that apply to them.

Russell Investments has resources dedicated to supporting the funds across many of its core functions, including Compliance, Finance, Legal, Operations, Product Management, Performance and Reporting, amongst others.

How much will the fee be and how will it be collected?

The fee charged will be 0.005% per annum. It will be applied to the net asset value of each impacted fund and capped at this level.

Funds impacted by this change are listed on the following page.

When will this take effect?

The fee will be applied to the funds from October 1st 2022.
